Essex Day Vendor Terms and Conditions

Dear Friends of Essex Day:

The New Essex Day Festival Association, Inc. is dedicated to the success of this festival and we are working to make your entire experience with us fun and profitable.

Please complete the enclosed application and return before August 15, 2018 with your check or money order. Please note the committee MUST approve your application, and just because you put in an application DOES NOT mean you're approved to be a vendor at Essex Day. You will receive an email denoting your status within approximately 15 days after we receive your application.

All vendors will be held accountable to adhere to the terms and conditions listed below:

1. Midway opens for set-up at 7:00 a.m. Enter via South Taylor Ave. You must enter midway and unload your vehicle at your assigned space. Remove vehicle from midway and return immediately to set up your space.
NO VEHICLES ARE PERMITTED ON THE MIDWAY AFTER 9:00 a.m.
2. Vendors must supply their own tables, chairs, tents and trash containers.
3. NO ELECTRICITY is available. If you will be using a generator you must note that on your contract.
4. Spaces will be guaranteed up to 15 ft. wide.
5. Fees are non-refundable.
6. **ALCOHOLIC BEVERAGES MAY NOT BE BROUGHT TO THE EVENT OR SOLD ON THE MIDWAY.**
7. Only food and beverage vendors may sell food and beverages, including soda and water. CANS OR PLASTIC ONLY — NO GLASS.
8. The Association has a right to restrict the sale of any item that may be considered harmful, destructive, or not in the best interest of the image of the Essex Day Festival.

9. You must leave your space clean and free of debris. Food vendors using any products such as grease MUST remove it from the site before leaving the Midway.
10. Additional spaces are available at same cost. This includes Non-Profits.
11. Food vendors are responsible to obtain and be approved by Baltimore County Office of Permits and Licenses.
12. Food vendors MUST display food permit on day of festival (MANDATORY).

IF A SITUATION ARISES, ONLY THE PEOPLE IN THE ASSOCIATION CAN ASSIGN AND/OR CHANGE FESTIVAL SPACES.

AT NO TIME MAY ANY VENDOR CHANGE HIS/HER ASSIGNED SPACE LOCATION OR THE ASSIGNED SPACE LOCATION OF ANOTHER VENDOR. IF AN ISSUE OCCURS PLEASE FIND AN ASSOCIATION MEMBER. PLEASE KEEP IN MIND WHEN APPROACHING US, ALL THE MEMBERS OF THE NEW ESSEX DAY ASSOCIATION ARE **ALL VOLUNTEERS** WORKING TOGETHER TO MAKE A GREAT EVENT FOR OUR COMMUNITY.
